**AMENDMENT NO. 1**

This Amendment No. 1 made this 13<sup>th</sup> day of October 2021 by and between Barnstable County (the "County") and **Borden & Remington Corp.** (the "Contractor") (collectively the "Parties") amends the Contract for Services Purchased Terms and Conditions made and entered into by the Parties on **July 10, 2021** (the "Contract").
